WARRANTY CERTIFICATE

3. To exercise this guarantee, the consumer must present the following at our company's headquarters: this document, the original purchase document (invoice or tax receipt) and the product (purchased together with the accessories).

 - d. Any defect caused by transport, falling, shocks after the date of purchase
 - e. Any defect due to negligence or improper storage
 - f. Returning the product without this certificate and the original purchase document
 - g. Using the product for purposes other than the one for which it was designed
 - h. Using batteries other than those recommended by the manufacturer

When changes, deletions or additions are made to this certificate regarding the date of purchase, the name of the buyer, the name of the selling company and their identification data or the series of the product, the buyer has the obligation to request the drawing up of a new warranty certificate: the documents showing changes/ erasures are null and void
6. KAS PLASTIK SAN. VE TIC A.S.'s responsibility regarding this guarantee is limited to the replacement of the product, being responsible for losses or damages of any kind caused to the buyer due to a hidden defect of the product.
